## Indemnity For Kids Safety

- No children are permitted to play in the kids church before the service commences.
- Children are to sit in the service with their parents until they are released to kids church
- If parents are NOT receiving prayer after the service, please collect your children immediately after the service.
- If parents wish to fellowship afterwards in the Café, the children will be permitted to play in the play area only if parents supervise them.
- Children running/playing throwing balls/toys etc in close proximity to people, (particularly the elderly) whilst utilizing the Café is strictly prohibited.
- Parents are required to notify us if their children have any allergies to certain foods.
- Parents are required to fill in and sign our release forms for any child to joining our kids church
- Parents are to check in and out there own kids
